Executive Summary

Advertising is dynamic and always changing, but some things never change.

Each year, the challenges filed and the decisions issued by BBB National Programs' National Advertising Division reflect matters that are deeply important to consumers, and 2025 was no exception. From pharmaceutical companies challenging prescription drug claims, big brands challenging smaller brands (and vice versa), and cases involving influencer disclosures, this was an active year all the way around.

In 2025, the makeup of incoming National Advertising Division cases did evolve. For instance, we received a large number of challenges involving health claims for significant medical conditions; we handled matters involving marketers of compounded GLP-1 medications, prescription drugs advertised to address important health concerns, and dietary supplements aimed at longevity and healthy living. We also saw many cases testing the bounds of influencer marketing and the circumstances that warrant clear and conspicuous disclosures.

2025 also brought us cases in new product sectors, including vacation rentals, retirement plans, and industrial safety equipment, demonstrating the broad reach of advertising self-regulation.

We rounded out our docket with a number of pricing, savings, and value decisions covering a variety of industries including telecom, business-related services, and credit cards, all indicating that kitchen table cost concerns are impactful to consumers and to the brands that provide them products and services.

Case Trends & Statistics

National Advertising Division (NAD) case decisions reflect the types of marketing and advertising that draw consumers' attention and purchasing dollars and provide a glimpse into what can be expected in 2026.

One trend we continue to see is the popularity of NAD's Fast-Track SWIFT, affirming the appeal to our stakeholders of this expedited process. We also saw an uptick in cases filed in the Complex Track, which provides greater flexibility in scheduling and expanded space for advocacy. NAD's monitoring matters continued to account for 20% of our decisions in 2025 and included several joint NAD/Children's Advertising Review Unit (CARU) inquiries.

There were several challengers and advertisers new to the NAD process this year, as well as challenges filed by public interest organizations or non-profits.

The range of cases brought before NAD is as varied as ever—spanning everything from cookware and teeth-whitening products to credit cards and business formation services. Top categories of challenges include dietary supplements and pharmaceutical drugs, cosmetic and personal care products, and telecommunications, including streaming and satellite services.

Influencer marketing is an ever-growing and indispensable tool for brands. Social media influencers represent over \$30B in global industry. But with great influence comes great responsibility. In June 2025, we published our "Influencer Trust Index: Consumer Insights," a comprehensive look at the state of consumer trust in influencer marketing today. The data show high consumer engagement with influencers yet shaky trust — only 5% of consumers surveyed completely trust influencer advertising, and 80% say the primary driver of distrust is when influencers are not genuine, honest, or transparent. Building on NAD's casework and research, BBB National Programs' Center for Industry Self-Regulation subsequently announced the creation of the **Institute for Responsible Influence**, which will provide influencers with training, certification, and ongoing resources, demonstrating that NAD's guidance helps build trust and increase transparency.

Made in USA (MUSA) claims are another area where transparency remains essential.



While the Federal Trade Commission (FTC) continues to emphasize scrutiny of U.S.-origin advertising, and declared July 2025 “Made in the USA Month,” NAD has long been a forum where these claims are tested in real-world disputes—and this past year brought additional MUSA cases to the docket.

These matters underscore that MUSA compliance can be nuanced, even for experienced brands and marketers. The takeaway is straightforward: ensure claims are accurate, learn from NAD’s decisions, understand how the FTC’s “screwdriver caveat” may apply, and consider the functionality and sourcing of key components when substantiating U.S.-origin messaging.

NAD is often called upon to address novel fact patterns—cases that shape how businesses communicate with consumers. We look forward to taking on the new challenges presented to us in the year ahead and continuing to serve our mission to enhance consumer trust in advertising and support fair competition in the marketplace.

National Advertising Division Monitoring Program

As part of its public interest mission to ensure consumers receive truthful and accurate advertising messages, the National Advertising Division (NAD) initiates approximately 20% of its cases each year based on its own monitoring of the marketplace. This work serves to expand the universe of advertising reviewed for truth and transparency and provides guidance for future advertising.

In determining whether to open a monitoring case, NAD considers whether the advertising targets a vulnerable population, capitalizes on consumer fears or misunderstanding, fills a gap in regulatory efforts of the FTC or state attorneys general, addresses novel or emerging issues of interest for the advertising industry, or addresses claims that consumers cannot evaluate for themselves.

In 2025, NAD's monitoring priorities continued in the health and wellness space as well as debt settlement companies. NAD also continued examining claims about artificial intelligence (AI) in a variety of industry sectors, reinforcing the message that advertising claims in emerging technologies must be supported.

In three related monitoring case decisions involving two brands and a celebrity influencer, NAD's decisions highlight the importance of ensuring that all players in the influencer ecosystem, including the influencer, make the required clear and conspicuous material connection disclosures.

National Advertising Division AI Monitoring Cases

As noted, 2025 brought a growth in NAD's focus on monitoring claims in the AI space. Cases focused on AI productivity tools and consumer products that integrate AI, such as smart phones, home appliances, and baby monitors. In this last category, NAD partnered with CARU on a decision related to AI claims made about a next-gen baby monitor.

The message for advertisers? Claims about AI must be substantiated when they are made, and they are evaluated under the same truth-in-advertising standards that apply to any emerging technology.

As AI becomes more complex—and more difficult for consumers to independently assess—the need for transparency only grows. These cases highlight the importance of ensuring AI-related messaging is accurate, appropriately qualified, and does not overstate the presence or benefits of AI features. At the same time, they point to an opportunity for brands to strengthen consumer trust by clearly explaining what their AI does, how it works, and what consumers can reasonably expect.

In its 2025 AI decisions, NAD found that certain claims were supported, while recommending modifications to other claims. In one matter, NAD recommended the advertiser modify a productivity claim because the supporting study demonstrated a perception of productivity that did not fit the objective claim. In another matter, NAD recommended the advertiser clearly and conspicuously disclose limits on the product's functionality. And in a third case, NAD emphasized that advertisers should not imply that features are available when they are not.

Building on years of experience around disclosures, NAD's AI cases also addressed when and how material limitations must be disclosed, especially where functionality or accuracy varies. As with any other claim, essential disclosures about AI must be clear, conspicuous, and proximate to the triggering claims.

National Advertising Division Highlights

At the Conference

Every year, BBB National Programs hosts the premier advertising law conference in the U.S., where leaders in industry and advertising law learn about and discuss cutting-edge and bread-and-butter claim substantiation issues. **NAD 2025: Leading the Way in Ad Law** took place in Washington, DC over two days in September. This annual event brought together advertising, legal, research, and development professionals, academic and industry experts, government officials, and businesses of all sizes to examine and explore the challenges of navigating the dynamic advertising landscape, best practices and trends, and perspectives on what's coming next.

BBB National Programs' President and CEO Eric D. Reicin kicked off Day 1 with opening remarks announcing the creation of the Institute for Responsible Influence, a new training and certification program to promote trust, transparency, and responsibility in the creator economy currently in development under the Center for Industry Self-Regulation, BBB National Programs' charitable foundation. Eric then introduced NAD's new Vice President, Phyllis Hurwitz Marcus, who served as host for the conference overall.

Our speakers included FTC Commissioner Mark R. Meador, providing the keynote address, and FTC Director of the Bureau of Consumer Protection, Christopher Mufarrige. Other presenters represented in-house brands, law firms, ad agencies, testing labs, and R&D teams.

The conference included for the first time a pre-conference workshop on NAD Fundamentals. This half-day interactive workshop provided attendees with perspectives on navigating the NAD process, the dispute resolution options available in the advertising space and how to manage client expectations, and practical tips on how to best prepare and respond to a case brought to NAD.

The two-day conference included mainstay panels such as the Year in Review and a deep dive into claim substantiation via the launch of a fictitious product. Additional panels covered topics including responsible strategies for marketing to teens, the rapidly evolving business of influencer marketing, how traditional advertising principles apply to emerging technologies, including AI and social



media, best practices for using consumer reviews in advertising, the unique challenges of marketing in highly regulated industries, how NAD evaluates complex, category-specific claims, an overview of the National Advertising Review Board appeals process, and the influence of NAD precedent on regulators and courts.

Throughout the conference, AI was front and center, from a creative keynote presentation to a separate session assessing the implications of its use in advertising. The conference concluded with Phyllis Hurwitz Marcus, alongside BBB National Programs' Executive Vice President, Policy, Mary Engle, sharing her vision for NAD going forward, including the role of NAD in sectors such as AI, financial services, retail, and private equity, and shared perspectives from Marcus and Engle on their time together at the FTC.

On the Road

In 2025, U.S. advertising self-regulation and NAD's experience that flows from 50+ years of truth-in-advertising case work, the single largest body interpreting advertising law in the nation, was featured on stages around the globe.



At conferences and events, NAD team members lent their voices to critical conversations on cutting-edge advertising law issues. In addition to sharing its expertise at industry and regulatory events, NAD also identifies emerging advertising law issues and trends and invites counsel, advertisers, academics, and regulators to topical virtual events addressing advertising law's hot topics.

Made in USA claims are ever present. In 2025, the FTC increased enforcement of its Made in USA Labeling Rule through initiatives like designating July as "Made in the USA Month" and issuing warning letters to companies and platforms for deceptive claims, reminding them of the rule that products must be "all or virtually all" U.S.-made to be labeled unqualifiedly as American-made.

BBB National Programs' Phyllis Hurwitz Marcus and Mary Engle participated in a conversation about this FTC initiative, breaking down what advertisers need to know about this important FTC Rule.


Closed Cases (Including Compliance)



Pending Cases




Cases by Track




Top Industries


Year-over-Year Trends
